

**Budget Meeting**  
**Stanley Town Office**  
**Wednesday, April 22, 2015 at 7:30 pm.**

Mayor Purdham called the meeting to order with the following Council Members in attendance: Mike Knight, Bruce Stoneberger, Mike Uram, and Martha Graves. Also present at this meeting were: Town Manager Terry Pettit, Accountant Leon Stout, Jim Ryan, Cindy Tate, Austin Good, Winfred Good, Donna Davis, Georgia Duncan.

Mayor Purdham called the Budget meeting to order at 7:30 pm and asked for a motion to appoint Leon Stout Temporary Clerk. Councilwoman Graves motioned for the appointment for Leon Stout to be appointed to Temporary Clerk and seconded by Councilman Stoneberger, passed unanimously.

Mr. Pettit noted that the Council has to make a decision for the Jim Ryan special use permit for the 2 duplexes to be built on Hilltop Circle. After a lengthy discussion, Councilman Knight motioned for passing the Jim Ryan Special Use permit. Vote for the special use permit failed for a lack of second motion.

Mayor Purdham asked for a motion denying the Jim Ryan special use permit. Councilman Uram motioned to deny the Jim Ryan special use permit. Vote failed for lack of second motion.

After a short discussion, Council decided to delay the Jim Ryan special use permit vote until the next council on May 20<sup>th</sup>, motion made by Councilman Uram and seconded by Councilman Stoneberger, passed unanimously.

Mr. Pettit noted that Heath Cave wanted to speak. Mr. Cave asked if the Council Would donated the use of the Ed Good shelter to have a fund raiser for Chad Cabbage, who is running for Sheriff. Mr. Pettit informed the Council of the price for the shelter was \$50.00. Mr. Cave said that he can cover the cost of the shelter because he did not realize the low cost of the shelter. Mr. Cave also asked if they could have booth at Homecoming. Mr. Pettit noted that he would have to contact the Homecoming Committee for the request.

Motion was made at 9:27 pm. by Councilwoman Graves, seconded by Councilman Uram that the Town Council convene in a Closed Meeting for the discussion of Legal Matters, as authorized by Virginia Code 2.2-311 Subsection A7. MOTION CARRIED.

Mayor Purdham states the Council is now in Open Meeting.

At 9:38 pm. Councilwoman Graves moved to Adopt a Resolution to certify the Closed Meeting; the meeting was held for purposes allowed under the Virginia Freedom

of Information Act and while in that Closed Meeting, only those matters identified in the Motion to hold a Closed Meeting were discussed, seconded by Councilman Knight.

Mr. Pettit noted that it was getting late. The council has a copy of the budget and can review it and we can reconvene on May 6 and discuss the budget further. The budget includes a raise of 4 %, new backhoe, new automated water meter system, pool repairs, and building repairs. After a short discussion the council proposed increases in water, cigarette tax, and meals tax.

Mayor Purdham adjourned the meeting at 10:00 pm.
